Attached is a copy of the revised Service Coordination Basic Agreement for individuals living in Supervised CRs and Supervised IRAs (MSC 5-Supr-SCBA) dated February 1, 2010. Two changes were made to the form based on language used in the MSC Vendor Manual Insert A (dated 8/19/09) and the new QM MSC Review Instrument distributed on January 26, 2010.

The form has been revised to state that the Service Coordination Agreement is required to be reviewed annually. The review is completed at the annual ISP review and noted on the third page of the form.
