OMRDD implemented fee increases for the Medicaid Service Coordination (MSC) program effective April 1, 2010. MSC Agency Executive Directors have been informed of the current MSC Level of Reimbursement fee status. The 4/1/10 fees incorporate a trend factor of 2.08 percent. The MSC Billing Chart, effective 4/1/10, is attached.
